a. <u>I-90 HPT Field Trip Planning:</u>

Brandon Rapez-Betty reported the field trip planning discussion is tabled, but will be discussed at a later meeting.

b. Kendall Yards Update:

Brandon Rapez-Betty provided data on the six-month analysis for the Kendall Yards Universal Transit Access Pass (UTAP) program. The program started in October and is invoiced monthly and adjusted annually. This was the fastest implementation of a UTAP program to date. Mr. Rapez-Betty reported that Kendall Yards UTAP has seen steady growth and presented a heat map depicting the areas of boarding's and noted the highest peak is in the afternoon. 80% of users are employees. The population eligible for the passes is 1600 with 1200-1300 of those being residents. Spokane Transit is looking into other prospective UTAP partners like Engie Insight, Providence Health and Services, MultiCare Health System, CHAS Health, and Travelers Insurance.
