a. Charter Update:

Beth Bousley reported that the Performance Monitoring and External Relations (PMER) Committee is aligning the CAC charter with current bylaws and resolutions regarding compensation for the CAC meeting. PMER voted to support the staff recommendation to change the compensation to the bus pass only. The committee motioned and approved to accept the amendment from PMER.

b. CCL Outreach Update:

Karl Otterstrom provided a CCL project update. The Small Starts Rating package has been submitted, engineering design is ongoing, environmental documentation was submitted and the Board is to review and approve a station customization policy framework. There will be an open house focused on station design and placement at Gonzaga University on October 18th from 4:30-6:30 pm at Cataldo Hall and the CAC members are invited. This open house will be advertised in the Spokesman-Review and to residents and property owners in the Central City Line corridor. Mr. Otterstrom reviewed different station concepts. The project should be complete in 2021. c. Fixed Route (FR) Passenger Survey Results:

Beth Bousley reviewed the survey results for the FR survey results. The survey showed overall satisfaction has remained very consistent and very good over five replications and further evidence by consistency and admirable ratings in the measuring of 11 service attributes. Passengers gave high ratings on how likely they were to recommend STA. Ms. Bousley reported that Driver driving safely, Driver courtesy, and Passenger personal safety on the bus rated the highest while the only attribute rated below 4.00 out of five points with 3.83 was Freedom from obnoxious behavior from other riders. Ms. Bousley reminded the committee of the successful courtesy campaign in conjunction with Eastern Washington University (EWU).

d. Recruitment/Orientation Update/Chair Vote:

Beth Bousley noted that new CAC member Michelle Rasmussen completed her orientation prior the meeting. Ms. Bousley mentioned Desautel Hege was working on widening the net in CAC recruitment efforts.

Charlie Howell announced it was time for election of the new chair. Victor Frazier moved to nominate Charlie Howell.

Beth Bousley suggested a substitute plan in case of his health and addressed the charter which states that the Chair or Chair's designee will be the appointed spokesperson for the CAC.

AGENDA ITEM 4b: 2018 SERVICE IMPROVEMENTS – PRELIMINARY PROPOSAL

SUMMARY: Based on years of input from citizens and technical preparation, the Spokane Transit Board of Directors approved a plan that aims to maintain the existing transit system while adding more resources where needed to improve service levels throughout the region. The *STA Moving Forward* plan, which is the basis of the voter approved STA Proposition 1 ballot measure, includes more than 25 projects to provide more and better transit service throughout the region.

With the voter approval of the STA Proposition 1, STA's service has made a number of service improvements in 2017. The multi-year implementation of *STA Moving Forward* projects began with some of the basic service improvements that were implemented in May and September of 2017. STA will bring even more *STA Moving Forward* enhancements to the transit system in 2018 as well as other individual route improvements not listed in *STA Moving Forward* in conjunction with ongoing scheduling adjustments as provided for in the board-adopted 2017 Transit Development Plan (TDP). Subsequent phases of the *STA Moving Forward* plan will be implemented throughout a ten-year plan horizon. Virtually every improvement in the *STA Moving Forward* plan will have an appropriately scaled public input process that precedes the implementation of the service or as specific design considerations are under evaluation. Voters' approval of the funding for *STA Moving Forward* represents more of a beginning to public input rather than the final decision.

Although many of the concepts listed in this Preliminary Proposal have been outlined in the *STA Moving Forward* plan or in the TDP, this September 2018 service change will be brought forward through a public process to receive public input before service can begin. The changes are considered moderate (between 1.0% and 5.0% growth or reduction in revenue hours of service in any calendar year) according to Policy 1.1 of the Communications and Public Input Element of STA's Comprehensive Plan. Required Board action is to be preceded by public outreach and a public hearing. The Preliminary Proposal represents a beginning point for public dialogue and input which will be critical for development of the Draft and Final Recommendations that will be published in February and April of 2018 respectively. The timeline for receiving public input, refining, approving, and implementing the proposal is provided below.

Proposal Overview

This Preliminary Proposal incorporates several fixed-route projects identified in *STA Moving Forward* to be implemented in 2018 as well as explores objectives listed in the Service Implementation Plan contained within the Transit Development Plan (TDP). The following improvements, in addition to routine service adjustments, have been identified in Appendix B of the *STA Moving Forward* plan:

- Improve weekday reliability for bus service on North Division Street in addition to improvements made in 2017 (Route 25)
- Add service on Indiana Avenue between Spokane Valley Mall and Greenacres Phase 2 Nights and weekends (*accomplished in 2017*)
- Add new night and weekend service to Indian Trail (Route 23)
- Add and improve service in West Central Spokane (frequency improvement proposed to be moved up from 2021)
- Expand and upgrade maintenance facilities to meet existing and projected growth requirements (no impact to routes)
- Construct the West Plains Transit Center at Exit 272 on I-90, and provide a Park & Ride for commuters (Phase 1 complete connectivity of West Plains cities is scheduled for 2020)

It should be noted that the Preliminary Proposal contains service concepts that could impact several routes serving the City of Cheney and the West Plains due to the West Plains Transit Center Park & Ride opening and the re-opening of the Eastern Washington University PUB.
